Tuition or Dinner?

We are planning another service initiative for October. Students take "hunger naps" because it is less painful to be asleep and hungry than it is to be awake and hungry.

In the coming weeks, university students will start class with great excitement and high hopes. But many of them will also be hungry.

A recent study by OSU determined that 15 percent of undergraduate students – approximately 7,000 – suffer from the effects of low food security. On-campus there exists an invisible student population who are experiencing food insecurity, the state of having limited or uncertain access to food. The issue is hard to see because of its cross-cutting nature and the fact that most students who are experiencing poverty want to keep it hidden due to stigma and shame. Regardless of its lack of visibility, the negative impacts of food insecurity on student success are real.

There is good news. OSU generously donated space to several ambitious students who feel that no student should go hungry, and the Buckeye Food Alliance (BFA) was born. Housed in Lincoln Tower, the BFA, driven by students for students, serves any currently enrolled student who does not have an Unlimited or Scarlet 14 meal plan. This student-run program services about 1,000 hungry students each year.

The UWC is conducting a Fall Food Drive to support the BFA in their effort to tackle student hunger. As a UWC Service Project, on October 7, 2019, at the UWC luncheon, we will be collecting food, boxing it and transporting it to Lincoln Tower. Students most request canned fruit. Canned meat and any type of dry pasta is also much appreciated. BFA believes that our UWC Fall Food Drive may provide the inventory to stock the shelves, making it possible for the BFA to open a second on-campus location.

Proposed Bylaw Amendments

Last year, 2018-2019 was a year of big changes for the University Women's Club. Many of the changes were geared to be in compliance with state regulations for a 501(c)3 organization and others were designed to modernize UWC, creating a more robust website, while still others were intended to update our organizations legal documentation, which included updating our *Bylaws*. Most importantly, all of these changes were designed to lead the UWC into the next 125 years!

This summary represents the year-long work of the Long range Planning Committee (LRP) chaired by Donna Cavell. The LRP did not take its responsibility lightly and gave considerable thought and consideration to the proposed amendments. The proposed changes were presented and discussed at the February 28, 2019, Executive Committee Meeting by the Chair of the LRP, and they passed unanimously by both the Executive Committee and the Annual Joint Board in toto. The membership will vote to approve these at the October 7, 2019 luncheon.

ARTICLE VII. APPOINTED POSITIONS

ARTICLE IX. INTEREST GROUPS

When ten (10) or more members in good standing wish to establish an Interest Group for any special purpose, a petition is to be submitted to the Executive Committee for forwarding to the Board for approval at the Joint Board Meeting in May or at a special meeting. It is preferred that the

chosen meeting day and time of the new interest group not conflict with an already established Interest Group. After approval by the Board, the *Bylaws* document of the new Interest Group is to be submitted to the Long Range Planning Committee for review.

Section 3. Governance

A. Interest Groups shall conform to the *Bylaws* that define their activities within the boundaries of the *Bylaws* of the Club. The Board of the Club shall approve amendments of Interest Group *Bylaws*.

Buckeye Bargains, (BB) the on-campus thrift store, is UWC's philanthropic arm to the OSU community. We had a stellar finish to last year. After a lucrative jewelry sale at the April luncheon, selling a Picasso poster print, a garage sale, a half-price sale day and then Bag Day. BB donated \$36,000 to the OSU Scholarship Fund.

Over the summer, the store was emptied of all merchandise, cleaned from wall to wall and restocked with member donations, estate sale remnants, and OSU Trademark and Licensing contributions. It is amazing how the shop was transformed over the summer months to be ready for the August opening. Customers were very happy to see our doors open on August 14th!



All UWC members are invited to come visit BB every Wednesday, from 9 a.m. – 3:30 p.m. On the first Wednesday of the month, we stay open until 5 p.m. There are two parking spots in front of the store that are free for 30 minutes if they are available. We are happy to pick up donated goods. Barb Herzog coordinated a pickup at Westminster Thurber and Goodale Landing and plans to do this on a bi-monthly basis. Interest groups can encourage their members to bring donations to interest group meetings and we can arrange a pickup. Are you or your neighbors downsizing?
